## **Capital Outlay**

#### **House Bill 2**

- \$8M total in capital outlay for the Power Complex
  - \$3M moved from Priority 5 to Priority 1
  - \$5M in cash reallocated to SWBNO
- **FINAL UPDATE**: Enrolled to become law (6/12/25)





## **SWBNO Bills**

#### **House Bill 190** (Civil Service | Rep. Hilferty)

- Repeals Act 384 of the 2024 Regular Session providing 1-year outline of transition from City Civil Service to State Civil Service (clean-up bill)
- Did not move out of House Municipal and Parochial Affairs
- FINAL UPDATE: Does not advance to become law

#### **House Bill 609** (Stormwater Fee | Rep. Landry)

- Requires SWBNO to assess a stormwater fee and gives Public Service Commission authority to regulate fee
- Deferred by House Municipal and Parochial Affairs
- FINAL UPDATE: Does not advance to become law

#### **House Bill 611** (Governance | Rep. Hilferty)

- Authorizes the Board to elect a president and employ legal counsel
- Deferred by House Municipal and Parochial Affairs
- FINAL UPDATE: Does not advance to become law



## **SWBNO Bills**

#### **House Bill 612** (Employment Lists | Rep. Hilferty)

- Requires SWBNO to establish and maintain employment lists containing names of persons eligible for appointment to various positions to be filled by the board
- Did not move out of House Municipal and Parochial Affairs
- FINAL UPDATE: Does not advance to become law

#### **Senate Bill 242** (Regulatory Authority | Sen. Owen)

- Gives the Public Service Commission authority to set water and sewer rates
- Deferred by Senate Local Affairs Committee
- FINAL UPDATE: Does not advance to become law



## **Other Utility-Related Bills**

#### **House Bill 6** (Nonpayment of Utility Bills | Rep. Jackson)

- Creates the crime of misappropriation of funds to address issues arising under rental agreements when landlords receive payment from tenants for utility services but fail to make the payment
- **FINAL UPDATE:** Enrolled to become law; Sent to the Governor (6/10/25)

#### **Senate Bill 2** (Water Fluoridation | Sen. Fesi)

- Prohibits fluoridation of any public water system unless approved by voters
- Passed by House but deferred by Senate Health and Welfare Committee
- FINAL UPDATE: Does not advance to become law

#### **Senate Bill 22** (Theft of Critical Infrastructure | Sen. Hodges)

- Creates the crime of theft of critical infrastructure
- **FINAL UPDATE:** Becomes Act 26; Effective 8/1/25



## **Other Utility-Related Bills**

#### **Senate Bill 63** (Lien for Nonpayment of Utility Bills | Sen. Jenkins)

- Creates a municipal privilege (lien) to collect against owners of multi-family residential properties for unpaid sewer and water bills
- FINAL UPDATE: Becomes Act 99; Effective 8/1/25

#### **Senate Bill 99** (Traffic Camera Revenue | Sen. Cathey)

- Removes carve-out for Orleans Parish that allows revenue generated by traffic enforcement devices outside of school zones to be used for stormwater drainage infrastructure, maintenance, and improvements
- FINAL UPDATE: Becomes Act 107; Effective 8/1/25

#### **Senate Bill 220** (Traffic Camera Revenue | Sen. Cathey)

- Reinstates carve-out for Orleans Parish that allows revenue generated by traffic enforcement devices outside of school zones to be used for stormwater drainage infrastructure, maintenance, and improvements
- **FINAL UPDATE**: Enrolled to become law (6/13/25)
